INFORMATION ABOUT CAMERA SYSTEM

This information serves as a basic overview about the operated camera system within the premises of the joint stock company *BONATRANS GROUP a.s.*, having its registered seat at the address Bohumín, Revoluční 1234, postcode: 735 94, Czech Republic, Business ID No: 274 38 678, entered in the Companies Register kept by the Regional Court in Ostrava, section B, inset 3173, as well as its legal subsidiary *Gutehoffnungshütte Radsatz GmbH* having its seat at the address: Gartenstrasse 40, 46145 Oberhausen, Germany, business ID No: DE811652483, registered in the commercial register of the local court in Duisburg under HRB 12743, (each of them hereafter also referred to as the "*Company*").

The Company hereby informs you that the operation of the camera system involves processing of personal data of persons entering grounds and premises of the Company consisting of the capture of their physical appearance on a camera recording.

I CONTROLLER

II PURPOSES OF PROCESSING

The purpose of personal data processing performed using the camera system is protection of life and health of persons, protection of property, protection against theft and protection against vandalism.

III SCOPE OF PROCESSING / CATEGORIES OF PERSONAL DATA

The physical image of a person on a video camera recording is processed.

IV PLACE OF PROCESSING

The data is processed at the registered seat of the respective Company:

- at the address Bohumín, Revoluční 1234, Czech Republic, postcode: 735 94, as for the camera system in the premises and/or buildings of BONATRANS GROUP a.s.;
- at the address Gartenstrasse 40, 46145 Oberhausen, Germany, as for the camera system in the premises and/or buildings of Gutehoffnungshütte Radsatz GmbH.

V RECIPIENTS

Recordings from the camera system are not passed on to third parties, with the exception of cases where this is required of the Company by the law or on its basis or on the basis of the decision of a public authority. In such a case, recordings from the camera system may be made accessible to, for example, criminal investigation and prosecution authorities or administrative bodies for the purposes of misdemeanour proceedings etc.

VI DESCRIPTION OF CAMERA LOCATION

Cameras are located in reception areas, attached to buildings at the entry to the premises and/or buildings and in the corridors in buildings. The places monitored by the camera system are marked with information signs. The location of cameras is available at the IT department of the Company.

VII DURATION OF KEEPING OF RECORDINGS

Recordings are recorded over on an ongoing basis on a loop. The recordings are kept for a maximum of 7 days from their making.

VIII REGIME OF CAMERA OPERATION

The cameras monitor the area non-stop.
